

SAIT PRIVACY CONSENT FORM

I understand and consent to the following:

- 1. The Scouts Australia Institute of Training RTO 5443 ('SAIT") may request membership and other personal details information from The Scout Association of Australia ('Scouts Australia') and its Branches and Officers as part of my enrolment with SAIT.
- 2. SAIT will collect and hold personal information about me as part of my enrolment and the services that SAIT provides. This information may come from a variety of sources including being directly provided by me through enrolment and other paperwork, assessment, and other interviews and processes. It may also be information supplied by Scouts Australia and its Branches directly to SAIT. All information collected will be handled according to the Privacy Act 1988 (Commonwealth), the Australian Privacy Principles and SAIT's Privacy Policy.
- 3. Some of the information collected may be of a sensitive nature, like health information, which SAIT will handle with particular care. I acknowledge and consent to SAIT collecting, using and disclosing my personal and sensitive information in accordance with the SAIT Privacy Policy.
- 4. The information collected and used by SAIT will be used to manage my enrolment and participation in the services that SAIT provides. SAIT will not use my information for any purpose not related to those provided services without my agreement unless required by law.
- 5. To assist in my enrolment and participation with SAIT, I acknowledge that SAIT may be required from time to time to provide my information to other third party organisations or support services to enable my further participation in the services that SAIT provides. I also understand that those third party organisations or support services may provide personal information or feedback to assist in my participation in SAIT's programs and services. Wherever reasonably practicable SAIT will endeavour to consult and seek consent to my personal information being provided to such third party organisations or support services to enable and support my participation in the services SAIT provides.
- 6. SAIT will, from time to time, be required to provide my personal information to Government agencies as required or authorised by law.
- 7. I understand that as part of my enrolment and participation with SAIT, SAIT may provide personal information to the Scout Association of Australia, and its Branches. I give SAIT permission to provide information about completed assessment, and qualifications and statements of attainment awarded to me, to the Branch or Branches of Scouts Australia of which I am a currently a member, or may be a member of in the future.
- 8. Candidates may be contacted from time to time to provide feedback and evaluation of the services provided by SAIT. This may be conducted internally by SAIT, or through an external third party who will conduct the collection of feedback and evaluation from candidates on behalf of SAIT. All external third parties that are engaged by SAIT for this purpose will be bound to handle my information in accordance with the SAIT Privacy Policy.

	I acknowledge that I have obtained a copy of both the SAIT Candidate's Information Handbook and the SAIT Privacy Policy and have read and understood the "Handling of my Personal Information" section of those documents.
